Well, here it is March of 1992 already. How many of you have sorted out all the research you did last fall?

I would like to give you a brief update on the Society. Because of rising costs of printing and postage we had to raise our membership dues to \$7.50. I'm so glad to see that membership is continuing to grow. We already have many new members for 1992. Welcome aboard! Membership is over 110 at present. Our genealogy library is available to all members and guests. It is housed in the basement of the Bloomfield Public Library.

One of our projects we hope to complete this year is a new microfilm reader-printer. We will be applying for a federal grant to help purchase this machine. The cost of it will be around \$5500 to \$6000. The grant will cover half of the cost. The sale of the 1882 History of Davis Co., IA. book last year and money from our treasury will be our half. If you would like to donate to this project send checks to the society at P.O. Box 94, Bloomfield, IA 52537.

As you will see, most of this newsletter is taken up with reports and information about the society. We felt that this information would help our members who are unable to attend meetings to keep involved with the society. Future newsletters will have more information on individual members and history of Davis County, Iowa. Hope you enjoy them. Any suggestions about what you would like to see printed are welcome.

Another project we have for this year is reading the cemeteries in Wyacondah, Fabius and Grove Townships. We will also be reprinting the W.P.A. Grave Registration records through the I.G.S. cost-share program. Cemeteries in Prairie and Roscoe Townships will be published through I.G.S. later this year.

BY-LAWS OF THE DAVIS COUNTY GENEALOGICAL SOCIETY

We, the members of the Davis County Genealogical Society wish to unite as an organization, to promote the study of genealogy, to preserve records of the past generations, and to assist one another in our constant search of personal genealogy, and we do hereby adopt this constitution and solemnly pledge ourselves to the utmost to be governed by its provisions.

ARTICLE I

Name and Location

- Sec. 1-1 The name of this organization shall be the Davis County Genealogical Society.
- Sec. 2-1 The principal office of the Society shall be located in the city of Bloomfield, Iowa.
- Sec. 3-1 The Society shall be a non-profit organization.

ARTICLE II

Objectives

1. To create and foster an interest in genealogy.
2. To observe and disseminate genealogical and historical data.
3. To aid individual members in compiling family genealogies.
4. To establish and maintain a genealogical library through donations, contributions and exchange.
5. To support the Iowa Genealogical Society.

ARTICLE III

Membership

Membership shall be open to all who are interested in genealogical, biographical and historical research.

ARTICLE IV

Officers

- Sec. 4-1 The Officers of this Society shall be President, Vice-President, Secretary-Treasurer and Librarian-Historian.
- Amendment VI: (11-20-86) "The offices of Secretary and Treasurer shall be combined as one office. All offices to be elective offices and all officers to be paid members."
- Amendment VIII: (11-20-86) "The offices of this Society shall be President, Vice-President, Secretary-Treasurer, Corresponding Secretary, and Librarian-Historian."
- Amendment X (11-15-90) "The officers of this Society shall be President, Vice-President, Secretary, Treasurer, Corresponding Secretary, and Librarian-Historian."
- Sec. 4-2 The Executive Committee shall consist of these elected officers, the past President, and another member from the membership. A majority shall constitute a quorum.
- Sec. 4-3 The term of office for the elective officers shall be for one year, from January 1 to December 31. An elective officer shall be limited to two (2) consecutive terms in the same office. In case of a vacancy occurring during the year, the Executive

Committee shall appoint a successor.

Amendment II: (11-17-77) "The office of Secretary and Treasurer shall be indefinite."

Amendment I: (11-17-77) "The office of Secretary-Treasurer shall be two (2) separate offices. All offices shall be elective, and all officers must be paid members."

ARTICLE V

Duties of the Officers

Sec. 5-1 The President shall preside at all meetings of the Society and of the Executive Committee. He shall appoint all committees, and in general see that the aims and projects of the Society are completed.

Sec. 5-2 The Vice-President shall be chairman of the program committee and shall assume the duties of the President when necessary.

Sec. 5-3 The Secretary shall keep the minutes of all meetings of the Society and conduct the correspondence. He or she shall be Treasurer, also, to receive all funds of the Society and disburse those funds as ordered by the Society or by the Executive Committee."

Amendment III: (11-17-77) "The Secretary shall keep the minutes of all meetings of the Society and conduct the correspondence. The Treasurer shall receive all funds of the Society and disburse those funds as ordered by the Society or Executive Committee."

Amendment VII: (11-20-86) "The Secretary shall keep the minutes of all meetings of the Society and conduct correspondence. He shall be Treasurer, i.e. receive all funds of the Society and disburse those funds as ordered by the Society or by the Executive Committee."

Sec. 5-4 The Librarian-Historian shall keep a record of the Society activities and a file of all especially prepared materials distributed to the members. He or she shall act as coordinator with the Public Library, to collect and keep an index of materials added to the library shelf, and make recommendations for books and materials to be purchased by the group. He or she shall serve, while in office, as chairman of the Chapter Library.

Sec. 5-5 The Corresponding Secretary shall conduct the correspondence of Society as required. Amendment IX: (11-20-86)

ARTICLE VI

Meetings and Elections

Sec. 6-1 Meetings of the Society shall be held monthly, on the third Thursday.

Sec. 6-2 The December meeting shall be the Annual Meeting. At this meeting all officers shall submit a written report of their activities in the Society for the past year. They shall complete their duties by January 1, and turn over to their successors all monies, records, files, and supplies.

Sec. 6-3 The election of the officers shall be held at the annual meeting. Election shall be by ballot. A majority vote shall elect. Nominations may be made from the floor.

ARTICLE VII
Committees

Sec. 7-1 The Executive Committee shall conduct the business of the Society between regular meetings. It shall have an authority to fill any vacancies which occur during an unexpired term.

Sec. 7-2 A Nomination Committee shall be appointed at the regular meeting in October. The Nominating committee shall submit names of members as candidates for each office. Candidates must have agreed to serve.

Sec. 7-3 Other Committees may be appointed as deemed advisable for the growth and success of the Society.

ARTICLE VIII
Dues

The dues shall be \$1.00 per year, per person, payable January 1 of each year. A list of paid-up members shall be furnished by the Treasurer at the February meeting.

Amendment IV: (3-20-80) "Effective January 1, 1980, dues shall be \$3.00 per year. All other items remain the same."

Amendment V: (8-20-83) "Effective January 1, 1984, dues shall be \$5.00 per year. All other items remain the same."

Amendment XI: (12-19-91) "The dues shall be \$7.50 per year, per person, payable January 1 of each year. A list of paid-up members shall be furnished by the treasurer at the February meeting."

ARTICLE IX
Amendments

This Constitution may be amended by two-thirds vote of the members present at two consecutive regular monthly meetings.

STANDING RULES

1. Roberts Rules of Order (Revised) shall govern the Society in all cases not provided for in this Constitution.

2. Agenda of regular meetings shall consist of a short business meeting, an educational or informative program, and a opportunity for time for the members to share and exchange information and ideas.

3. All members joining the Society during the first year, 1974, shall be considered Charter Members.
