Friends had long felt slavery was wrong and worked in many ways to help the slaves. The majority of the Friends would not have refused shelter to an escaped slave, if shelter was needed, but did not believe it right to violate the laws of the land to do so. Thus the problem arose over how one should deal with the slavery issue. Some put more action behind their words than others, including breaking the law and thus the riff. Most Friends could be called Abolitionist but we generally refer to those who were very involved in the Underground Railroad as Abolitionist.

I began with Lewis Savage's extractions (* by those on his list).

I added more names and copied the actual minutes, which follow this listing; page numbers to those minutes.

This list lists many (not all) of those who were disowned during the Anti-Slavery (Separatists) Division Period. {Microfilm at times is very hard to read and those disowned at times hard to find or understand the action taken}

Some you easily can see were not involved with the Separatist and some you cannot.

Those whose names are in red, the actual minutes show,
were involved with the Separatists (Abolitionists) Monthly Meeting. I could 48 names.

When you see "presented an offering" this means he/she signed a statement which said he/she was sorry for his/her action(s) and if the monthly meeting accepted his/her apology he/she was reunited with the society. You will see, added in green, that many of those who separated over the slavery issue came back.
