

THE LIFE STORY OF —

**Lyle E. Armentrout, 68**

Lyle Ellis Armentrout, son of Ralph E. and Laura Petersen Armentrout was born Nov. 20, 1913 on a farm in Shelby co. He attended the country school, later graduating from Irwin high school in 1931. He then went into farming.

On June 20, 1940, he married Pauline Humphreys at Denison. They adopted a son, Lee. After their marriage, Lyle continued to farm near Irwin, and did so for many years. In 1973, they retired, and in 1976, they moved into Irwin. This has been their home since that time.

He attended the Church of Christ in Irwin. He was a member of the Sardius Lodge No. 444, A.F. & A.M. and the Eastern Star, Chapter No. 182, O.E.S., both of Irwin. He had also served on the Irwin school board. He died in Irwin on Monday, Oct. 4, 1982 at the age of 68 years.

In addition to his parents, he was preceded in death by one sister, Alice Hansen. He is survived by his wife, Pauline of Irwin; his son, Lee of Denison; aunts, uncles, cousins and other relatives.

Funeral services were held at the Church of Christ in Irwin on Thursday, Oct. 7, 1982 with Pastor Jeff Wilson officiating. Burial was in Oak Hill cemetery in Irwin with Leslie Brue, Dean Downing, Normal Richards, Vernon Campbell, Carroll Kallevig and Clarence Campbell serving as casketbearers. Masonic rites were conducted at the cemetery by the Sardius Lodge No. 444, A.F. & A.M. of Irwin.
