She attended country school until the age of seven when the family moved to Arlington. She graduated from Arlington high school in 1915. She attended college at Grinnell college, Grinnell, Northwestern University, Evanston, Ill.; Pamona college, Pamona, Calif., University of Nebraska, Lincoln, Neb. and Midland College, Fremont, Neb. Eve taught music at the Oregon school for the blind in Salem, Oreg. and also in the Arlington school system.

She married Jasper Hobson Ludwig, April 18, 1927 in Arlington. They took up residency in Chicago, Ill., until the fall of 1944, when they moved to Fremont, Neb., where Mr Ludwig was employed by Marshall Nurseries of Arlington, a business founded by Eva's father. Hosten died on Dec. 16, 1982.

Phoenix, Ariz., was her home for the next 21 years before moving to Irwin in March of 1978. She was a member of the Irwin United Methodist church, the American Legion Auxiliary and the Fremont Chapter of the Order of Eastern Star. While living in Ariz., she was very active in the WWI Veterans Auxiliary where she served as State Musician. Everywhere she resided she was always involved in the musical organizations of her community and her church.

She died on Wednesday, June 15, 1983, at the Manilla Manor Nursing Home, Manilla, at the age of 85 years, 5 months, 2 days. Preceding her in death were her parents; two sisters, Herma Gail Johnson and Leta Jane Marshall; brothers, Floyd and Earl Marshall who died in infancy; and her husband.

Surviving her are her three daughters, Margaret Mary, Mrs John Anderson, Irwin, Constance Joyce, Mrs Gerald Anderson, Fremont, Neb. and Eunice Irene, Mrs Donald Gandre, of Green Bay, Wisc.; 12 grandchildren and six great-grandchildren along with many other relatives.

Funeral services were held Saturday, June 18, 1983 at the United Methodist church in Irwin, with Rev. Leon Wallace, officiating.

A second service was held Saturday, June 18, 1983 at the Arlington Community church, Arlington, Neb. with Rev. Dr. Gene Laramy, officiating.

Burial was at the Arlington cemetery with Barry, Earl and John Anderson, Carl Willadsen, Robert C. Mortensen and Martin and Michael Anderson, David Gobar and R. Michael Prether and Kent Johnson serving as casketbearers.
