## Car, cycle collide; Harlan man killed

Donald J. Trierweiler, 48, of Harlan faces charges of operating while intoxicated (OWI) and homicide by vehicle in connection with a carmotorcycle accident Sunday night that claimed the life of David J. Wingert of

Wingert, 20, of 1308 16th St., died late Sunday evening of major multiple injuries received when the motorcycle he was operating collided with a car driven by Trierweiler, a resident of 3002-36 12th St.

The accident occurred at 10:09 p.m., 1 1/2 miles south of Harlan on Highway 59 near the entrance to the Country Care Center Corporation (formerly the Shelby County Care Facility).

Shelby County Deputy Sheriff John Kelly said the car driven by Trierweiler was southbound on U.S. Highway 59 when he attempted to make a left turn to enter the CCCC and entered the path of the Wingert motorcycle.

Investigators said it did not appear that

Wingert was wearing a helmet.

He was taken by Life Flight Helicopter to St. Joseph Hospital in Omaha, NE., where he died shortly after arrival.

Trierweiler was not injured. He was incarcerated overnight at the Shelby County Jail and appeared at a bond review hearing Monday afternoon at the Shelby County Courthouse.

Kelly said homicide by vehicle is a Class D felony carrying a maximum

penalty of five years in prison.

Property damage estimates were placed at \$1,000 to the vehicle driven by Treierweiler, a '77 Oldsmobile owned by Mary Ann Ballantyne of Harlan; and \$2,500 to the '85 Honda motorcycle operated by Wingert.

Assisting in the investigation at the scene were Sheriff Gene Cavenaugh and Chief Deputy Mark Hervey of the Shelby County Sheriff's Department; Patrolmen Bill Bartelson and Mike Bratcher, and Sgt. Kevin Petty of the Harlan Police Department. Helping with traffic control were two members of the Harlan Police Department Explorers Post.
