Sylvester Haynes is Dead

Prominent Farmer Near Cumming

Succumbs Suddenly Yesterday

Resided there since 1874.

Sylvester Haynes, one of the best known farmers in the vicinity of Cumming, died suddenly at his home one mile south of Cumming early yesterday morning. While he has not been in his usual health the past summer, his death was entirely unexpected. The funeral arrangements have not yet been made.

He has lived on the same farm since 1874 and has always been regarded as a most successful farmer. He owned the farm of 160 acres where he lived and another of eighty acres in that vicinity. He leaves a wife and a large family of grown children.

This community was startled Friday morning by the announcement of the death of Mr. Sylvester Haines an old and respected citizen of this place. He was in his usual health and took suddenly ill with neuralgia of the stomach. Dr. Cochran was called immediately, but the pain reached his heart in a short time and medical aid availed nothing. He died in a few hours surrounded by his wife and family, who are all grown up. Mr. Haines was a good neighbor, a very indulgent father and husband and the whole community sympathizes with this family in their sore bereavement. His remains were interred in the cemetery at Orillia.

Whereas, Sylvester Haynes, late of Warren County, Iowa, died intestate about December 16, 1904, leaving surviving him as his widow Sarah C. Haynes, who now resides on the farm and on the old homestead, and the following children and only heirs at law, to-wit:

Irwin W. Haynes, Mary E. Haynes, Edward G. Haynes, George Fredrick Haynes, Effie J. Haynes, Edith C. Haynes, Clarence F. Haynes and Charles M. Haynes, all of whom are adults, and that he died seized in fee of the following described real estate, situated in the County of Warren and State of Iowa, to-wit:

The South West Quarter (1/4) of Section Seventeen (17), (except thee right of way of the Chicago & Great Western Railway Company) and the South West Quarter (1/4) of the North East Quarter (1/4) of Section Twenty (20) (except the School House site of One acre in the North West corner thereof,) all in Township Seventy Seven (77) North, of Range Twenty Five (25) West of the 5th P.M. Iowa, Ald also, Lot Eight (8) in Block (1) in the town of Cumming, Warren County, Iowa. And also left the personal property situated upon the said farm, and an amount of money in bank.

That administration has begun by the filing of a petition asking for the appointment of Irwin W. Haynes as the administrator of said estate.

That it is understood that aside from the balance due on a mortgage on a part of the lands hereinbefore described, that there is a little indebtedness, and it is believed that the personal estate will be sufficient, if all sold now, to pay for the said debts. And that it is the desire of the widow and all of the children and heirs at law, all of whom are adults, that the property belonging to the estate of Sylvester Haynes, deceased be not divided, nor that any part of it be sold or disposed of, except so much as of the personal property as may be thought advisable, when ready for market, to be applied on the debts and on the mortgage on said lands.

And further, it is desired that the property, all of it, both real and personal, be left and remain in the hands of Sarah C. Haynes to be by her used, managed and controlled during her life time in the same general way in which it has been managed and used heretofore and by the said Sylvester Haynes in his life time. And that upon the death of the said Sarah C. Haynes, the widow, that the property then be converted into money, or divided equally between all of the children as herein named. And that the administration be had, so far as the payment and settlement of all legal claims against the estate of Sylvester Haynes, and that no property be used or sold, save what may be necessary to be so used by the administrator in making such settlement.

And further, that the said Sarah C. Haynes is to relinquish her right of dower or distributive share in and to said estate, both real and personal, and in lieu thereof is to have and receive a life estate in and to all of said property, with the full and perfect right to the use of such of the said property, and the income thereof, as may be proper, reasonable and necessary for her comfort, maintenance and support during her entire life, and for the payment of her last sickness and funeral expenses. And that this contract shall be so constructed and held as placing said property in the hands of the said Sarah C. Haynes for and during her life time, and also as a relinquishment of any other or different rights which she might have than that of said life estate. And that the said administrator, when appointed shall settle and dispose of the said estate upon all the terms and conditions hereof, and be entitled to his discharge when all of the debts costs and claims against said estate have been fully paid, and the time has elapsed in which he would be entitled to a discharge, and the retention by the said Sarah C. Haynes of all property, will be a sufficient voucher in the hands of the said administrator upon final settlement.

There was 2 more pages to this document and was signed by all of the children. On the 21st day of January 1905 it was signed and subscribed by the official seal at Cumming, Iowa.

There was a complete list of cash received on day of sale and farm proceeds and a list of other expenses paid.
